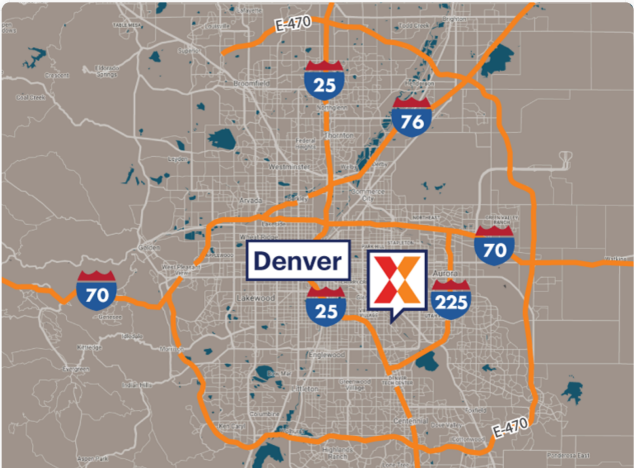

- Located across the street from brand-new 287-unit apartment complex

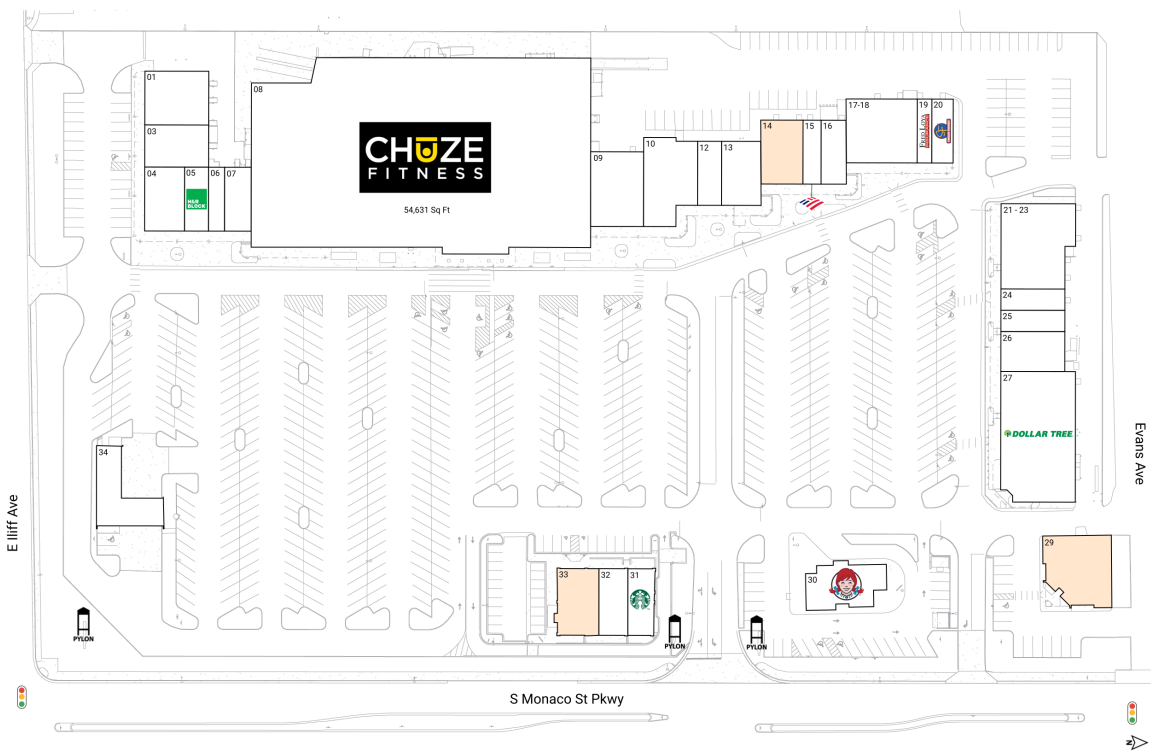
