Easily accessible from the 66,000 vehicles per day on I-91, via both Lower Westfield Road and Cherry Street (Kalibrate 2021)

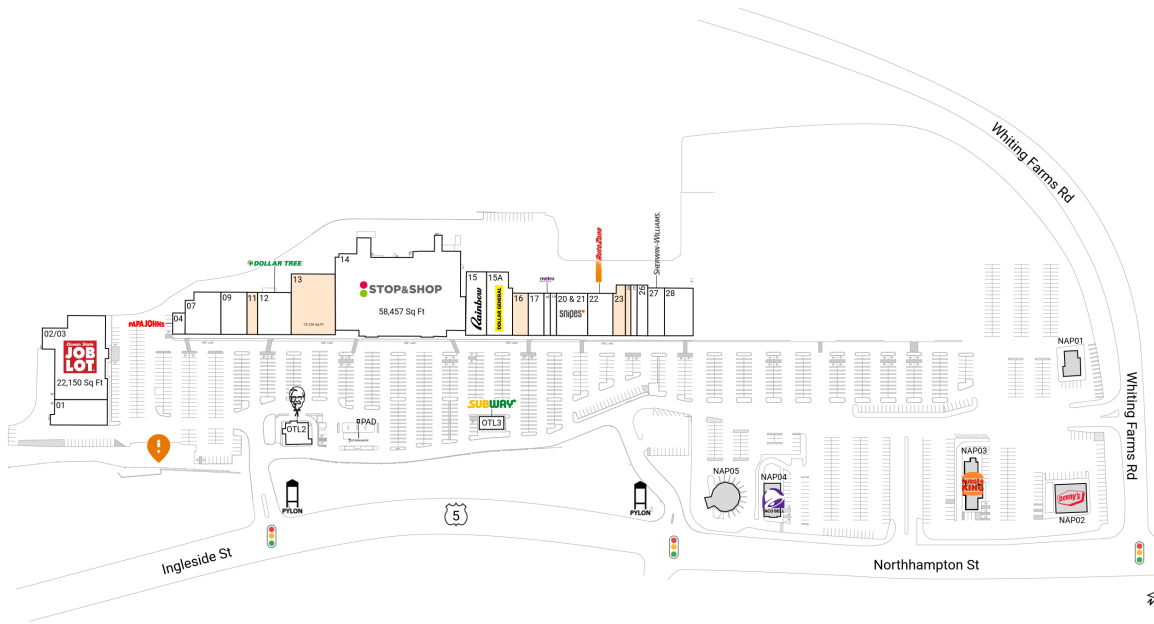
