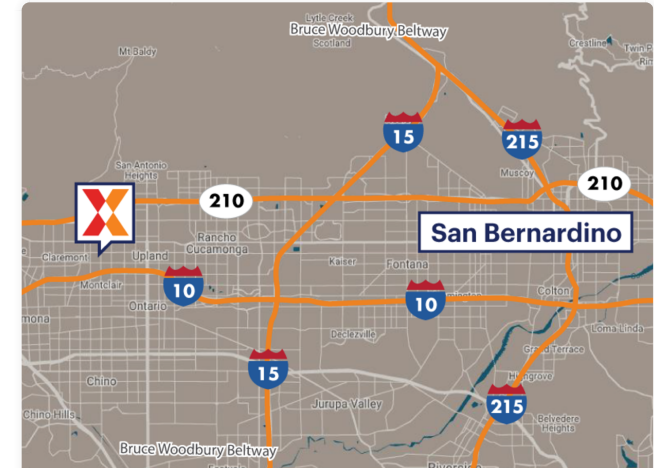

Within 2 miles of I-10 and Fwy 210 on the main retail corridor in the Inland Empire

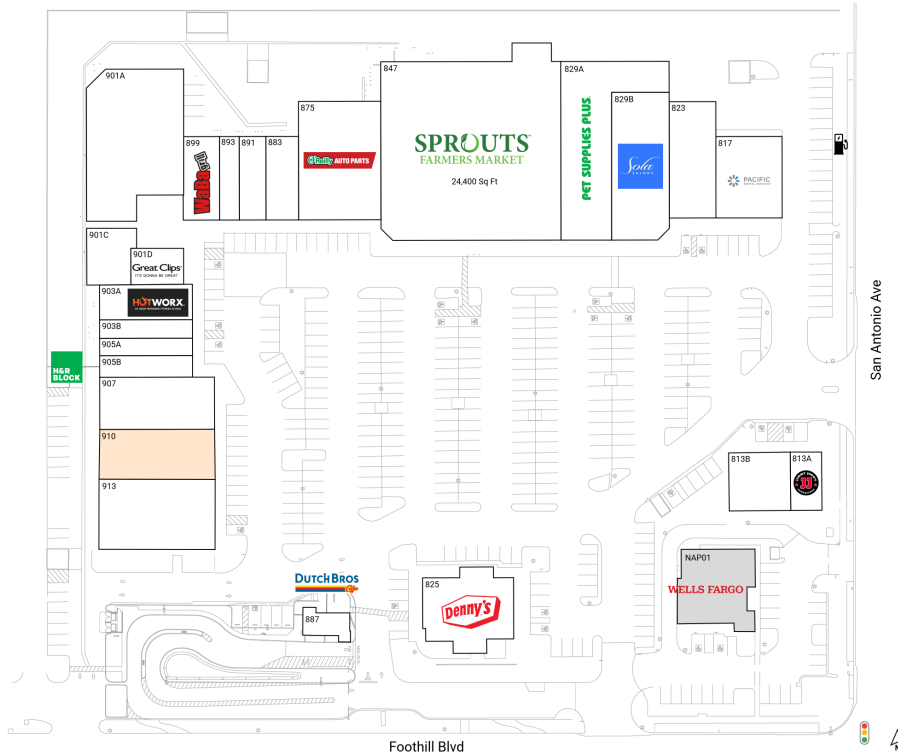
